- 1. Call to Order:** The meeting was called to order at 7:15 pm by David Fedash, LCAM from Ameri-Tech.
- 2. Proof of Notice:** Fedash stated Proof of Notice of the meeting was mailed on December 13, 2022, as required, and will be kept in the official association records.

- 4. Approval of January 11, 2022 Annual Meeting minutes** – Reading of the January 11, 2022 Annual minutes was waived. Tuccio motioned to approve the 2022 Annual meeting minutes and, Carver seconded. All approved.
- 5. Call for Nominations form the floor** – Fedash asked if any nominations from the floor... None were made. Current Board will stay on and in the same position and one intent by Rick (Kenneth) Husk will be added as a Board member. No election this year, the number of intents, nominations did not exceed the number of vacancies that exist on the Board.
- 6. Introduction of 2023 Board of directors:** The current Board of Directors will stay in same positions and Husk is added as a Director on the Board.
